Girls 14-and-under Singles Championships

Open to girls attending school in California who were born on or after May 1, 1997. The entries in this event are limited. Players must not enter any other event. Your entry must be mailed to: OVTC, P.O. Box 482, Ojai, CA 93024, by April 6, 2012. Each entry must enclose a photocopy of your USTA card (which must be current through the entire tournament period). No players passes will be issued, so your USTA card or other ID will be required to gain free entry to sites where spectator admission is charged. Juniors start play at 8:00 a.m. on Thursday. You can obtain your first match time from the tournament website, www.ojaitourney.org, by Tuesday of tournament week and proceed directly to the court location, or you can obtain directions Thursday morning at Libbey Park. No school uniforms are allowed in this event. Coaching is allowed only between the second and third sets. In addition to winner and runner-up awards, the Rotary Club of Ojai Trophy will be awarded in the 14-and-under Girls Singles Championships.
